Prohibited uses

1. You may use our site only for lawful purposes. You may not use our site:
2. In any way that breaches any applicable local, national or international law or regulation.
3. In any way that is unlawful or fraudulent, or has any unlawful or fraudulent purpose or effect.
4. For the purpose of harming or attempting to harm minors in any way.
5. To send, knowingly receive, upload, download, use or re-use any material which does not comply with our content standards (see Contents Standards paragraph further down this document).
6. To transmit, or procure the sending of, any unsolicited or unauthorised advertising or promotional material or any other form of similar solicitation (spam).

7. To transmit unlawful material or material that is defamatory, threatening, discriminatory, extremist or which has the potential to radicalise themselves or others.
8. To transmit material that infringes the intellectual property rights or privacy rights of a third party, or that is in breach of a legal duty owed to another party.
9. To knowingly transmit any data, send or upload any material that contains viruses, Trojan horses, worms, time-bombs, keystroke loggers, spyware, adware or any other harmful programs or similar computer code designed to adversely affect the operation of any computer software or hardware.

You also agree:

Not to access without authority, interfere with, damage or disrupt:

any part of our site;

any equipment or network on which our site is stored;

Interactive services

18. Promote sexually explicit material.

19. Promote violence.

20. Promote discrimination based on race, sex, religion, nationality, disability, sexual orientation or age.

21. Infringe any copyright, database right or trade mark of any other person.

22. Be likely to deceive any person.

23. Be made in breach of any legal duty owed to a third party, such as a contractual duty or a duty of confidence.

24. Promote any illegal activity.

25. Be threatening, abuse or invade another's privacy, or cause annoyance, inconvenience or needless anxiety.

26. Be likely to harass, upset, embarrass, alarm or annoy any other person.

27. Be used to impersonate any person, or to misrepresent your identity or affiliation with any person.

28. Give the impression that they emanate from us, if this is not the case.

29. Advocate, promote or assist any unlawful act such as (by way of example only) copyright infringement or computer misuse.

Suspension and termination

We will determine, in our discretion, whether there has been a breach of this acceptable use policy through your use of our site. When a breach of this policy has occurred, we may take such action as we deem appropriate.

Failure to comply with this acceptable use policy constitutes a material breach of the terms of use <https://nabas.co.uk/policies/NABAS-Website-Terms-of-Use.pdf> upon which you are permitted to use our site, and may result in our taking all or any of the following actions:

Immediate, temporary or permanent withdrawal of your right to use our site.

Immediate, temporary or permanent removal of any posting or material uploaded by you to our site.

Issue of a warning to you.

Legal proceedings against you for reimbursement of all costs on an indemnity basis (including, but not limited to, reasonable administrative and legal costs) resulting from the breach.
